This letter is in response to your June 04, 2013, "open record request" letter which was received by the Office of the Attorney General, on June 10, 2013. In your open records request you ask for the following:

Copies of all documents that you have provided, or will provide, in response to the letter, dated on or about May 7, 2013, from U.S. Representatives Bob Goodlatte and Trent Franks, which requested a range of information related to abortion in the state of KY.

Our office has determined that we possess 2 pages of documents responsive to your request. The usual cost for these documents would be \$.20 (2 pages at \$.20 per copy). However, our office is waiving the cost due to the minimal expense.


Our office also acknowledges that this open records response is late due to an administration error. We apologize for any inconvenience this may have caused you.
